## SUB:-Request for CGHS facility to MTNL Mumbai Pensioners

This Association represents the combined service pensioners (retired Executives) of MTNL Mumbai.

There are about 14000 combined service pensioners (both executives and non executives together) retired from MTNL Mumbai till date and their pension is governed by Rule 37 A of CCS Pension Rules'72. The MTNL pensioners are eligible to get CGHS facility as per para 4(a) of Department of Health and Family welfare letter no.15025/28/2013-CGHS III dated 9th January 2014 as they are in receipt of Central Civil pension from Central Civil Estimates under Major Head -2071.

On their retirement, the IDA Pay scales are mapped to CDA Pay Scales vide Department of Telecom OM No. 4-12(11)/2012-PAT(Part) dated 31/08/2016. This OM has been endorsed by CGHS Directorate.

DoT has issued another OM vide No.4-12(11)/2012-PAT(Pt) dated 18/10/2016. As per this OM the following are to be mentioned in the PPO.

- 1. Corresponding Grade Pay as per Annexure A-1 and Annexure A-2 of OM dated 31/08/2016 for the purpose of deciding contribution rate.
- 2. Corresponding range of Pay drawn in pay band in CDA (excluding grade pay) as per Annexure B-1 and B-2 of OM dated 31/08/2016 for deciding the entitlement of wards

CCA Delhi is issuing a Sheet (forms part of PPO) mentioning the above mapping and CGHS Delhi at R.K.Puram has accepted this as sufficient for issuing CGHS Cards. CGHS Cards are issued to combined service pensioners of MTNL Delhi from 01/01/2017.

CCA Maharashtra Circle Mumbai has agreed to follow the same procedure to issue Pay mapping sheet (part of PPO). MTNL Mumbai will issue NOC as employer.

Therefore our Association requests your kindselves to replicate the procedure being followed by CGHS R.K. Puram Delhi and start extending the CGHS facility to the combined service pensioners of MTNL Mumbai.
