In Accordance with the above cited reference, the following guidelines were issued by Pr. CCA, MH Circle for submission of Life Certificate by MTNL pensioners.

1) The Pensioner has to appear in person before A.O. (PDA) and submit Life Certificate in the month of November 2016 in the prescribed format (copy enclosed).

2) The Pensioners who are unable to attend office in person due to illness, disability etc., may send their life certificates in the prescribed proforma as per Central Treasury Rules.

3) A life Certificate issued online by a Government Agency as a result of Aadhar Biometric Authentication will also accepted as a valid certificate.

Wide publicity may kindly be given to all the pensioners for using the format provided by CCA, MH Circle. MTNL units are authorised to collect Life Certificate complete in all respects and forward the same on the next day to AO (PDA) from 01/11/2016 to 15/11/2016. MTNL absorbed officers are not authorised to sign the Life Certificate.

Further the Office O/o. Pr. CCA, MH Circle, Curry Road will remain open on all Saturdays in the month of November 2016 for receipt of Life Certificates. The office will remain closed on Holidays & Sundays (Viz. Sunday:-06/11/2016, Sunday:-13/11/2016, Holiday:- Guru Nanak Jayanti 14/11/2016, Sunday:-20/11/2016 & Sunday:-27/11/2016).
