Respected Sir,

On behalf of all members of this Association I greet you on your promotion and assumption of charge as Principal CCA Maharashtra Circle Mumbai.

Kindly recall our discussions on 20/04/2016. In the discussions the office bearers of RTOWA emphasised the importance and urgency of the following issues.

Drawal and payment of arrears of Pension to pre 01/01/2007 retirees and issue of PPOs to all the pre 01/04/2014 retirees:

There are about 6600 pensioners including family pensioners retired prior to 01/01/2007 entitled to get arrears for 69 months from 01/01/2007 to 30/09/2012 due to revision of pension effective from 01/01/2007. Out of these 6600 pensioners about 500 pensioners only have been paid arrears so far. Most of these pensioners are more than 70 years old and are going through the last chapter in their life.

Government PPOs are to be issued to about 11500 pensioners including the above 6600 pensioners retired prior to 01/04/2014. Out of these about 2000 PPOs only have been issued so far.

It is observed that the main hindrance is un availability of the system for these works for about 10 days every month. There seems to be genuine problems mainly due to inadequacy of hardwares and unreliability of softwares. Augmenting the capacity of Servers and continuous and effective co-ordination with MTNL may mitigate this problem. Using the services of retired personnel of DoT/BSNL/MTNL may also help to expedite this work.
