### This has reference to above mentioned letters on the subject.

The Corporate Office issued clarification in respect of VRS Optees and the same was implemented accordingly. However, approximately 29 cases are pending for financial upgradation till date including retired officers and working officers due to non-completion of 2 weeks mandatory training.

The detailed list of the Retired officers is enclosed at Annexure-A and Working officers is enclosed at Annexure- B with reason mentioned in the column for non-completion of training.

The matter has been deliberated in this office and following proposal is being again resubmitted for consideration and approval of the Competent Authority:

One time relaxation of the training condition may be considered in respect of those officers (Working and Retired) who completed their training after stipulated date or did not complete any training after previous upgradations. The above relaxation may be extended to the cases prior to 31/01/2020 to have parity with VRS Optees. The working officers having service of more than 2 years may be allowed to complete their left over training within 6 months of time without affecting the date of upgradation.

After receipt of the above sought one time relaxation, cases included in the Annexure-A and Annexure-B shall be settled accordingly. However, any other case which is not included here but is of similar nature shall also be settled accordingly.
