Respected Sir,

Sub:- Payment of Salary for Jan'20 / Feb'20 and payment of GPF, Leave Encashment etc to pensioners on superannuation and on VRS and other issues.

Kindly consider the following issues.

- 1. PAYMENTS:-
- 1.1 It is regret to say that the assurances to pay salary on time have not materialized. Now two months' salary is due to the employees and one month salary is due to the VRS pensioners.
- 1.2 GPF final payment and Leave encashment to the pensioners on superannuation since July'2019 and to the pensioners on VRS are due.
- 1.3 Payment of Salary arrears and leave encashment arrears for the pensioners retired during 01/01/2018 to 31/07/2018 are pending for last more than one year.
- 1.4 Reimbursement of OPD bills and telephone bills to the pensioners are pending for more thanone year.
- 1.5 Reimbursement of 50% CGHS Contribution to the pensioners is pending for more than one year.

We request you to fix up a time schedule for payment of all these dues to the Employees and Pensioners.

2. WAIVAL OF TRAINING CONDITIONS: There are a few cases where the training condition is not yet waived. Due to non waiver of training conditions, the pensionary benefits of a few pensioners have not yet been settled for more than 8 months. A few employees have not been given time bound promotion though the DPC is over as the condition of training is not fulfilled. It is requested that one time relaxation of all such cases may kindly be given.

- 3. It is learnt that DOT has called for some information from MTNL regarding sanction 5% IDA neuralization to the pensioners retired prior to 01/01/2018. MTNL Mumbai has already furnished the information to Corporate office. It is requested to give positive response to DOT's query immediately as the issue is pending more than 2 years.
- 4. CGHS Mumbai is ready to open a wellness center at Borivili if site is available. CGHS authorities had identified Ground floor at Borivili telephone exchange is a suitable location for CGHS wellness Center to serve beneficiaries coming all the way from Virar and beyond. Setting up wellness center at Borivili Telephone Exchange complex will attract more number of retired employees roughly amount to 5000 from the western suburbs It is requested to offer this site to CGHS for opening a new wellness center.
- 5. It is learnt that premium towards CGHIS has not been paid to the Insurance company for some of the applicants. The point is pensioners should not be deprived off the medical facility because of non-payment of premium by MTNL.
