Sub: NOC and Conversion of Category for Residential Service Telephone Connection /Broadband Connection for VRS Optees after 31/01/2020.

With reference to the above subject, the following procedures are to be followed in respect of residential service telephone connection (landline/BB/Mobile) to VRS Optees under VRS 2019:-

- A) The employees residing in BSNL area and MTNL area who wants to retain their Residential Service Telephone Connection (RSTC) after VRS: They have to apply for retention of RSTC to competent authority in enclosed format and the approval may be sent to concerned authority for conversion of category from RSTC/FRSTC/CTC to Retired Category Telephone Connection.
- B) The employees residing in MTNL area and having BB connection at their residence provided on additional rent free Incoming only Telephone Connection on paid basis have to apply for retention of the same on plain paper for conversion to Retired Category.
- C) No NOC is required for the employees who are staying in BSNL area.
- D) In case of employees who are residing in MTNL area, the concerned Admn. Unit may take the NOC from concerned AO (TR) in respect of outstanding dues, if any for RSTC/FRSTC/CTC/BB connections.
- E) The concerned Admn. Unit should make the consolidated list of the employees who have requested for retention of RSTC/FRSTC/CTC/BB connections and sent it to DGM (TR)/CSMS for conversion of category from RSTC/FRSTC/CTC/BB connections to Retired Category Telephone Connection w.e.f. 01/02/2020. The format is enclosed herewith.

It is requested that all the above exercise should be completed before $\frac{15}{01}$, 2020.
