In continuation to this office letter dt. 27.12.2019, it is to inform that WFMS unit has made modification in the system for issue of Provisional Last Pay Certificate to VRS optee/ Retirees to enable them to enroll in CGHS (Central Government Health Scheme) on the basis of LPC.

Concerned DM (Cash/Works) are requested to issue Provisional Last Pay Certificate, to those VRS optee/ Retiree who wish to apply for CGHS.

Flow: LPC can be taken from WFMS: Payroll \rightarrow 15, Report \rightarrow 2.

All SM (Admn) are requested to provide Assistance cum Help Desk for Enrollment in CGHS to VRS optee/ Retiree to fill up ONLINE CGHS form, as already conveyed previously by this office.

The pro-rata optees, who have taken VRS and submitted option for CGHS, such employees have to take requisite proforma letter i.e. "certificate for issue of CGHS card" from O/o. Dy. CCA, DoT, Pension Section, Currey Road, Mumbai, before submitting online CGHS enrollment form.

Direct Recruitee appointed by MTNL after 1.11.1998 are not eligible for availing CGHS facility. Such employees can enroll only in CGHIS (Contributory Group Health Insurance Scheme) presently offered by United India Insurance Company through TPA. Such Direct Recruitee VRS optees who have unknowingly submitted option for CGHS are not eligible for CGHS and they have to submit CGHIS enrollment form (UIIC/TPA).
