Since the process has been done out of WFMS system, the manual accounting entries will be done centrally and ATs will be raised to units. The units may update the recovery schedule and necessary certificate may be issued wherever required. The salient features of the 2^{nd} installment Exgratia payment are as below:

- 1. The total VRS-2019 retirees are 8193 and Exgratia payment released for 8143 retirees. The balance 50 retirees whose strike off order issued provisionally, pension forms not submitted and retirees expired where dues are to be settled to legal heir are not considered.
- 2. The Exgratia payment released proportionately to 8143 retirees as per the funds allotted.

3. The recoveries made from the Exgratia are as per the inputs given by the P&A units, in case of any excess/wrong deduction units may settled at their level.

4. The Half Pay Leave recasting recovery has been recovered from the Exgratia, the correctness of the same may be verified by the units and in case of any short/excess payment necessary rectification may be carried out at unit level.

5. The society dues recovered as per the inputs received from the MTNL Credit society.

6. The TDS has been deducted @31.2% on payable Exgratia amount with consideration of excess tax deducted in Leave Encashment due to DOT leave period exemption wherever units has corrected in WFMS.

7. The 2nd Exgratia installment calculation sheet will be made available on portal "pensioner.mtnl.in" in due course. In case of any queries from retirees may be settled at the unit level.

8. The 1st installment and 2nd installment will be adjusted at the time of Final Exgratia settlement. In case of any excess payment, the same will be recovered from the other retirement benefits.

9. In case of non receipt of payment, the retirees may be asked to approach AO (Cash) HQ on 022-24312999.
